Lewis And Clark Trail Museum, Alexander, Adds Colorful Mural To Attract Visitors

The Lewis and Clark Trail Museum, Alexander, has been adding more and more to the grounds, and now they have a brand new painted wall that depicts a colorful timeline of the area.

The mural is located on the north wall of the museum. It includes paintings of Lewis and Clark, Sakakawea, and Lewis' dog, Seaman, on the Little Missouri River, a tipi, an

old homestead, barn and windmill, a prairie rose, the Badlands, bison, an oil well pump jack, combine, grain elevators, and some horses and cowboys.

"One of the things I think is really cool about the mural is that there is an American flag painted on the window, which is on the top level, and at night it lights up so that everyone is able to see the bright colors," said Cathy White, Lewis and

Clark Trail Museum director.

The artwork was done by a local artist, James Griffin. White added, "He has his own company called, Griffin Artwork and Custom Designs; he is a very talented artist!"

The Lewis and Clark Trail Museum Board of Directors decided to add a colorful mural to the museum to draw people's attention to it. White said, "The board wanted to incorporate some-

thing that would add some color to the museum, and we thought that a mural would be a great idea. We also wanted it to follow a timeline from the early settlers to the current day and the artist did a great job incorporating all of that into the mural. In the future, visitors will also be able to see a pollinating garden along with eleven crops."

Richland County COVID-19 Update Aug. 14 Active 3, Recovered 45, Deaths 2, Total 50

The Richland County Health Department is announcing additional active cases of COVID-19 in Richland County residents. This brings the total case count to 50. At this time, 45 of the total cases are recovered, and three are active, with two deaths.

Active case updates are as follows:

Case 50: A male in his 40s who is not hospitalized and is isolating at home. The case investigation is ongoing and contact tracing has begun. The individual was symptomatic.

Case 49: A male in his 60s who is not hospitalized and is isolating at home. The case investigation is ongoing and contact tracing has begun. The individual was named as a contact to a positive case and became positive in quarantine.

Case 48: A female in her 30s who is not hospitalized and is isolating at home. The case investigation has begun. The individual was symptomatic.

The Health Department continues to monitor up to 30 close contacts daily. The Health Department's investigations show that residents could be doing more to follow COVID-19 preventative recommendations, particularly in regard to not

going out when sick, staying home after being tested, and avoiding large gatherings.

It is imperative that Richland County residents follow instructions from the Health Department and healthcare providers. The following are important reminders:

- If you are not feeling well, particularly including symptoms of a dry cough, fever, shortness of breath, headache, and other cold-like symptoms, stay home until you feel better. This means that you do not go to work, do not attend regular activities, and cancel or postpone appointments.

- If you have been tested for COVID-19 for any reason, including preper-

ative testing, you must stay home until test results are received. This means that you do not go to work, do not attend regular activities, and cancel or postpone appointments.

- All residents should be practicing social distancing, including limiting the number of close contacts. This means avoiding large gatherings where social distancing is difficult. Wear a mask as required and when social distancing is difficult.

Together we can slow the spread of COVID-19 in our community. Please do your part so Richland County can recover socially and economically from this pandemic.

Burning Ordinance Richland County

The Richland County Commissioners approved the first reading of a new ordinance on Monday to establish open burning regulations, a county burn permit system and a penalty for violations.

Commissioners explained that there has been a burn permit system, but a penalty wasn't established. "As an ordinance, there can be a penalty to it," Commissioner Duane Mitchell said. "So, there's teeth to it."

According to the proposed ordinance, a person could face up to six months in the county jail, be fined up to \$500 or both.

The second reading is scheduled for Aug. 31. Public comment will be allowed.

County officials explain that the ordinance is part of a review of policies to update all ordinances.

The ordinance states that a person who ignites or sets fire, including a slash-burning fire, land-clearing fire, debris-burning fire, or open fire on any residential or commercial property, forest, range or cropland without first having obtained a written permit or permission from the recognized protection agency for that protection area to ignite or set the fire is guilty of a misdemeanor.

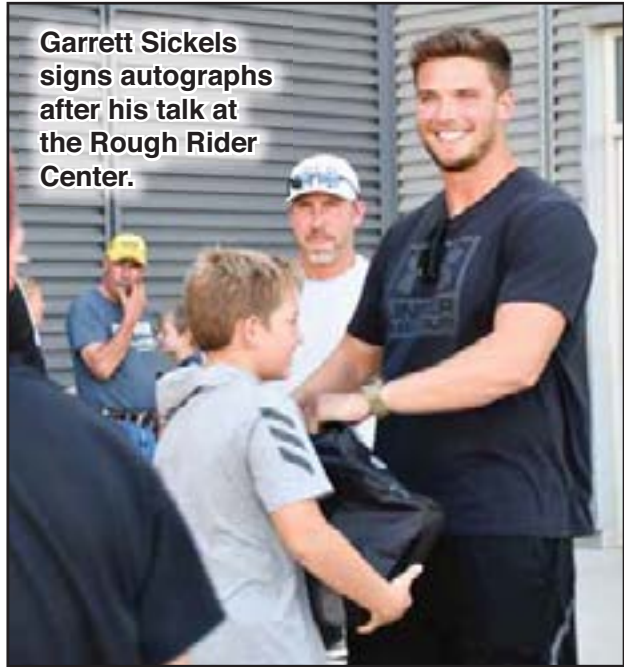
An individual who purposely ignites a fire in violation of this section shall reimburse the county governing body or recognized protection agency for costs incurred for any fire suppression activities resulting from the illegal fire.

Keystone XL Pipeline Joint Notice of Permit Pending

The proposed Keystone XL Pipeline Project (Project) within the United States would be located in Montana, South Dakota, and Nebraska, connecting to the existing Keystone Cushing Extension pipeline, which extends from Steele City, NE, to Cushing, OK. In total, the Project would consist of approximately 1,209 miles of new, 36-inch-diameter pipeline, with approximately 327 miles of pipeline in Canada and approximately 882 miles in the United States (US). The project would cross the international border between Saskatchewan, Canada, and the US near Morgan, MT, and would include pipeline generally within a 110-foot-wide temporary construction right-of-way (ROW) and a 50-foot-wide permanent ROW in Montana, South Dakota, and Nebraska. The approximate start of the project in Montana is located at the following coordinates: 48.99, -107.54. The approximate end of the project in Nebraska is located at the following coordinates: 40.04, -96.99.

McKenzie County Healthcare Systems Now Offers Suboxone Clinic

McKenzie County Healthcare Systems Inc. (MCHS) has added many different services to their clinic, and more recently, they have implemented a Suboxone Clinic. This is a program offered to people who are seeking treatment for substance abuse. Anyone who struggles with pain medication addiction or physical or psychological dependence with morphine, dilaudid, methadone, heroin, kratom, codeine, oxycodone, or opioids is encouraged to take advantage of the Suboxone Clinic.

The idea for establishing this program stemmed from a passion of MCHS Doctor, Warren Looney, M.D. He started the Suboxone Clinic to help people in Watford City and western North Dakota who have challenges with substance abuse. Dr. Looney said, "I want people to know there is help and resources available out there for those who struggle with substance abuse and there are opportunities that can help them live a normal life without those substances."

According to www.rehabcenter.net, suboxone is a medication used to alleviate or reduce withdrawal symptoms from heroin or other opioids. Suboxone contains both buprenorphine and naloxone. Buprenorphine is an opioid medication, and naloxone blocks the effects of opioid medication, including pain relief or feelings that can lead to opioid abuse. "Opiates are one of the hardest drugs to get off, and most people who try to get off of them experience bad withdrawal symptoms, so Suboxone is made to help alleviate some of the withdrawal symptoms that users will experience when coming off of an opiate."

The Suboxone Clinic is designed to help patients get their lives back while being part of a practical, doable, and effective treatment program that allows the patient to maintain their day-to-day relationships and lifestyle. "Addiction

is a very dysfunctional disease; it does not only affect the individual - it affects almost every aspect of their life. Substance abuse is not an issue of will power - they cannot stop

on their own - when it comes to this "disease" they need help," explained Dr. Looney.

Like the Suboxone Clinic, medically assisted treatment programs have been shown to be the most effective way to treat addiction. Dr. Looney explained, "It is becoming more and more popular nationwide as it is determined to be the most likely avenue for a successful recovery. But in order for the program to be effective, patients have to be compliant and be willing to make their appointments."

Local Support For Volunteer Program

Northeast MT RSVP volunteer program has received two separate funding donations to help support their efforts responding to COVID relief and to support their work with area veterans. In May, Lance Jackson, Montana-Dakota Utilities (MDU) reached out to RSVP program staff with a funding opportunity to support RSVP's efforts in responding to volunteer needs that were misplaced due to the shut-down and provide supplies to essential workers. In a separate funding opportunity, the RSVP program staff presented a proposal to the Sidney Elks Lodge to support a Richland County Day of Service Event. The event would be open to the public with specific services

Public Input on Historic Preservation Sought For North Dakota

Bismarck, ND – The North Dakota State Historic Preservation Office (NDSHPO) and the State Historical Society of North Dakota invite the public to provide input on a survey of historic preservation goals and activities for the five-year period beginning Jan. 1, 2022. The survey can be accessed at www.surveymonkey.com/r/M95B23D. Responses will be collected through Jan. 1, 2021, and will be used to determine the future of historic preservation in the State.

Periodic updating of North Dakota's comprehensive historic preservation plan is a federal requirement for the state's participation in the National Historic Preservation Program. Annually, this program brings approximately \$750,000 into the state to underwrite building restorations, historic property surveys, National Register of Historic Places nominations, Certified Local Government initiatives, site protection programs, and technical assistance to the public.

The plan is written in broad terms and is intended to provide general guidance to the preservation program in North Dakota. Annually, NDSHPO more fully develops goals and objectives cited in this plan, which incorporates feedback from a survey of preservation professionals, state and local leaders, owners of historic properties, and the general public.

USDA Accepting Applications To Help Cover Costs For Organic Certification

Submitted by Lindsey Abentroth
Washington - USDA's Farm Service Agency (FSA) announced that organic producers and handlers can apply for federal funds to assist with the cost of receiving and maintaining organic certification through the Organic Certification Cost Share Program (OCCSP). Applications for eligible certification expenses paid between Oct. 1, 2019, and Sept. 30, 2020, are due Oct. 31, 2020.

"For producers producing food with organic certification, this program helps cover a portion of those certification costs," FSA Administrator Richard Fordyce said. "Contact your local FSA county office to learn more about this program and other valuable USDA resources, like farm loans and conservation assistance, that can help you succeed." OCCSP provides

cost-share assistance to producers and handlers of agricultural products for the costs of obtaining or maintaining organic certification under the USDA's National Organic Program. Eligible producers include any certified producers or handlers who have paid organic certification fees to a USDA-accredited certifying agent. Eligible expenses for cost-share reimbursement include application fees, inspection costs, fees related to equivalency agreement and arrangement requirements, travel expenses for inspectors, user fees, sales assessments and postage.

Due to expected participation levels and the limited funds available, FSA revised the reimbursement amount available through fiscal year 2023. Certified producers and handlers are now eligible to receive reimbursement for up to 50% of the certified organic operation's eligible expenses, up to a maximum of \$500 per scope.

cost-share assistance to producers and handlers of agricultural products for the costs of obtaining or maintaining organic certification under the USDA's National Organic Program. Eligible producers include any certified producers or handlers who have paid organic certification fees to a USDA-accredited certifying agent. Eligible expenses for cost-share reimbursement include application fees, inspection costs, fees related to equivalency agreement and arrangement requirements, travel expenses for inspectors, user fees, sales assessments and postage.

Due to expected participation levels and the limited funds available, FSA revised the reimbursement amount available through fiscal year 2023. Certified producers and handlers are now eligible to receive reimbursement for up to 50% of the certified organic operation's eligible expenses, up to a maximum of \$500 per scope.

This change will allow a larger number of certified organic operations to receive assistance. If Congress authorizes additional funding, FSA may provide additional assistance to certified operations that have applied for OCCSP, not to exceed 75% of their eligible costs, up to \$750 per scope.

The changes to the payment calculation and maximum payment amount are applicable to all certified organic operations, regardless of whether they apply through an FSA county office or a participating state agency. State agencies that are interested in overseeing reimbursements to producers and handlers in their states must establish new agreements with FSA for fiscal 2020.

This announcement also includes the opportunity for state agencies to apply for grant agreements to administer the OCCSP program in fiscal 2020. State agencies that establish agreements may be able to extend their agreements and receive additional funds to administer the program in future years.

FSA has not yet determined whether an additional application period will be announced for state agencies that choose not to participate in fiscal 2020. States that would like to administer OCCSP for multiple years are encouraged to establish an agreement for fiscal 2020.

FSA will accept applications from state agencies from Aug. 10, 2020 through Sept. 9, 2020.

State Agencies must submit the application for federal assistance (Standard Form 424 and 424B) electronically via Grants.gov, the Federal grants website, at <http://www.grants.gov>.

To learn more about organic certification cost share, please visit the OCCSP webpage, view the notice of funds availability on the Federal Register, or contact the FSA county office at your local USDA Service Center. All USDA Service Centers are open for business, including some that are open to visitors to conduct business in person by appointment only. All Service Center visitors wishing to conduct business with FSA, Natural Resources Conservation Service or any other Service Center agency should call ahead and schedule an appointment. Service Centers that are open for appointments will pre-screen visitors based on health concerns or recent travel, and visitors must adhere to social distancing guidelines. Visitors may also be required to wear a face covering during their appointment.

DLI applies for "Lost Wage Assistance" UI funds

HELENA – The Montana Department of Labor & Industry (DLI) announced it has applied for the Lost Wages Assistance Payments grant through the Federal Emergency Management Administration (FEMA).

Upon approval, this grant will allow DLI to provide an additional \$400 per week in assistance payment to those receiving Unemployment Insurance (UI) benefits due to COVID-related impacts. FEMA disaster relief funds will cover \$300 of the new weekly payment and the other \$100 will come from Montana's allocation of the federal CARES Act Coronavirus Relief Fund. Lost Wage Assistance was established after Congress did not reauthorize the Federal Pandemic Unemployment Compensation program, which provided an extra \$600 payment to eligible UI claimants.

"DLI will work as quickly as possible once our

application is approved to distribute the extra payments to Montanans," Acting DLI Commissioner Brenda Nordlund said. "The federal government is requiring states to program a new system, and DLI is already implementing the necessary changes to get this money out the door."

To qualify for this additional funding, claimants must self-certify that they are unemployed or partially unemployed due to disruptions caused by COVID-19.

The first week for which the Lost Wages Assistance payment will be available is UI benefit week ending Aug. 1. DLI will provide retroactive payments to eligible claimants from that week forward. The duration of payment is dependent on the terms of the President's Memorandum. The payment could end in a matter of weeks, if FEMA funding is exhausted or the federal government enacts new law, similar to the recently expired Federal

Pandemic Unemployment Compensation program, to supplant the Lost Wages Assistance payment. It will end no later than Dec. 27, 2020.

DLI continues to encourage anyone who believes they may be eligible for UI to file a claim online at MontanaWorks.gov, or at mtpua.mt.gov for those that fall under the Pandemic Unemployment Assistance

eligibility guidelines. Those with technical, eligibility, or benefits questions are encouraged to view the COVID-19 resource website at dli.mt.gov/covid-19. A variety of information for both Montana workers and employers is available, and resources to help claimants navigate the unemployment process.

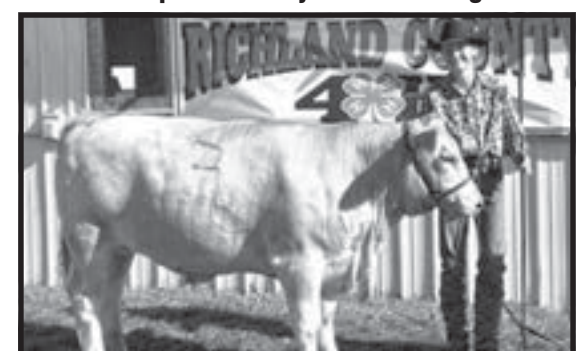

Montana FSA: USDA Announces More Eligible Commodities For CFAP

Application Deadline Extended to Sept. 11, and Producers Who Have Approved Applications to Receive Final Payments

Washington, DC - U.S. Secretary of Agriculture Sonny Perdue announced that additional commodities are covered by the Coronavirus Food Assistance Program (CFAP) in response to public comments and data. Additionally, the U.S. Department of Agriculture (USDA) is extending the deadline to apply for the program to Sept. 11, and producers with approved applications will receive their final payment. After reviewing over 1,700 responses, even more farmers and ranchers will have the opportunity for assistance to help keep operations afloat during these tough times.

"President Trump is standing with America's farmers and ranchers to ensure they get through this pandemic and continue to produce enough food and fiber to feed America and the world. That is why he authorized this \$16 billion of direct support in the CFAP program and today we are pleased to add additional commodities eligible to receive much needed assistance," said Secretary Perdue. "CFAP is just one of the many ways USDA is helping producers weather the impacts of the pandemic. From deferring payments on loans to adding flexibilities to crop insurance and reporting deadlines, USDA has been leveraging many tools to help producers."

Background:
USDA collected comments and supporting data for consideration of additional commodities through June 22, 2020. The following additional commodities are now eligible for CFAP:

- Specialty Crops - aloe leaves, bananas, batatas, bok choy, carambola (star fruit), cherimoya, chervil (french parsley), citron, curry leaves, daikon, dates, dill, donqua (winter melon), dragon fruit (red pitaya), endive, escarole, filberts, frisee, horseradish, kohlrabi, kumquats, leeks, mamey sapote, maple sap (for maple syrup), mesclun mix, microgreens, nectaries, parsley, persimmons, plantains, pomegranates, pumpkins, pumpkins, rutabagas, shallots, tangelos, turnips/celeriac, turmeric, upland/winter cress, water cress, yautia/malanga, and yuca/cassava.
- Non-Specialty Crops and Livestock - liquid eggs, frozen eggs and all sheep. Only lambs and yearlings (sheep less than two years

- Aquaculture - catfish, crawfish, largemouth bass and carp sold live as food fish, hybrid striped bass, red drum, salmon, sturgeon, tilapia, trout, ornamental/tropical fish, and recreational sportfish.
- Nursery Crops and Flowers - nursery crops and cut flowers.

Other changes to CFAP include:

- Seven commodities — onions (green), pistachios, peppermint, spearmint, walnuts and watermelons — are now eligible for Coronavirus Aid, Relief, and Economic Stability (CARES) Act funding for sales losses. Originally, these commodities were only eligible for payments on marketing

Governor Bullock Directs \$50 Million To Maintain, Expand Child Care & Support Montana Families

Funding will be available beginning Aug. 19, and allocated as follows:

- \$30 million in grants to maintain and expand child care for school-age children during out of school time. Applications for this portion of the funding will be available online at covidrelief.mt.gov beginning on Aug. 19.
- \$10 million for families with special circumstances requiring in-home care. Applications will be available online on the DPHHS Child Care Resource and Referral Agency (CCR&R) website page beginning on Aug. 19.
- \$8 million for supplemental payments to all licensed and registered childcare facilities to maintain and expand childcare slots. These payments will start to be processed on Sept. 1.
- \$2 million for CCR&R agencies for administration and outreach.

adjustments.

- Correcting payment rates for onions (green), pistachios, peppermint, spearmint, walnuts, and watermelons.

Additional details can be found in the Federal Register in the Notice of Funding Availability and Final Rule Correction and at www.farmers.gov/cfap.

Producers Who Have Applied:

To ensure availability of funding, producers with approved applications initially received 80% of their payments. The Farm Service Agency (FSA) will automatically issue the remaining 20% of the calculated payment to eligible producers. Going forward, producers who apply for CFAP will receive 100% of their total payment, not to exceed the payment limit, when their applications are approved.

Applying for CFAP:

Producers, especially those who have not worked with FSA previously, are recommended to call 877-508-8364 to begin the application process. An FSA staff member can help producers start their application during the phone call.

On farmers.gov/cfap, producers can:

- Download the AD-3114 application form and manually complete the form to submit to their local USDA Service Center by mail, electronically or by hand delivery to their local office or office drop box.
- Complete the application form using the CFAP Application Generator and Payment Calculator. This Excel workbook allows customers to input information specific to their operation to determine estimated payments and populate the application form, which can be printed, then signed and submitted to their local USDA Service Center.

- If producers have login credentials known as eAuthentication, they can use the online CFAP Application Portal to certify eligible commodities online, digitally sign applications and submit directly to the local USDA Service Center.

All other eligibility forms, such as those related to adjusted gross income and payment information, can be downloaded from farmers.gov/cfap. For existing FSA customers, these documents are likely already on file.

All USDA Service Centers are open for business, including some that are open to visitors to conduct business in person by appointment only. All Service Center visitors wishing to conduct business with FSA, Natural Resources

Conservation Service or any other Service Center agency should call ahead and schedule an appointment. Service Centers that are open for appointments will pre-screen visitors based on health concerns or recent travel, and visitors must adhere to social distancing guidelines. Our program delivery staff will be in the office, and they will be working with our producers in the office, by phone and using online tools. 

DPHHS Issues Statement Regarding Flavored Electronic Smoking Device Proposed Rule

Director Sheila Hogan sent this notification to the Children, Families, Health and Human Services Interim Committee regarding MAR Notice No. 37-923:
I'm writing to notify you that the department is withdrawing MAR Notice No. 37-923 from consideration and will not be adopting the proposed rules. After this week's interim committee meeting it is apparent that more education and

collaboration is necessary to protect Montana kids from the epidemic of e-cigarette use through this proposed rule, in spite of the latest study which came out this week showing that teens and young adults who vape are five times more likely to become infected with coronavirus than those who don't. DPHHS will continue to work with partners, including the legislature, to protect the health of Montana's greatest asset—its kids.
Statement from DPHHS Director Sheila Hogan:
"The anticipated polling of the legislature revealed that

additional education and collaboration is necessary to protect Montana's next generation, in spite of the latest study which came out this week showing that teens and young adults who vape are five times more likely to become infected with coronavirus than those who don't. DPHHS will continue to work with partners, including the legislature, to protect the health of Montana's greatest asset – its kids."

ND Federal Duck Stamp Required Sept. 1

Waterfowl hunters age 16 and older are reminded a federal duck stamp is required beginning Sept. 1. Waterfowl includes ducks, geese, swans, mergansers and coots.

This year's 2020-21 federal duck stamp is available for electronic purchase through the North Dakota Game and Fish Department's website, gf.nd.gov, instant licensing telephone number, 800-406-6409, or at license vendors registered with the department's licensing system. Physical stamps are not available at North Dakota license vendors, but they can still be purchased at many U.S. Postal Service offices.

The electronic stamp is a purchase item like any other hunting or fishing license. When the purchase is completed the electronic stamp is valid immediately. Federal Duck Stamp will be printed on the license certificate, along with an expiration date 45 days from the date of purchase. The actual physical stamp will be sent by postal mail.

The physical stamp is processed and sent by the official duck stamp vendor in Texas, and should arrive to the individual buyer well before the expiration date printed on the electronic license. The physical stamp must remain in possession of the hunter after the 45-day electronic stamp has expired. Individuals who have questions regarding the status of their physical stamp can contact the federal duck stamp vendor customer service number at 800-852-4897.

The federal duck stamp has a fee of \$25. An additional \$1.50 fee is added to cover shipping and handling costs of the physical stamp.

Hunters Should Check For Closures Due To Wildfires Before Going Afield In Montana

Several wildfires are active in Montana, and this can affect land access for hunters in some areas.

Wildfire activity can change rapidly, and some fires may limit public access to roads and areas of public land. Wildfires can also cause closures on block management areas during hunting season. Hunters should check for closures due to wildfires before traveling.

Recreationists can view an interactive map of active wildfires in Montana by visiting <https://inciweb.nwcg.gov/>. If a fire is active near where you plan to hunt, contact the local office of the applicable land management agency to check for closures.

Hunters should also check for closures on block management areas, as well as fishing access sites, wildlife management areas and other areas administered by Montana Fish, Wildlife & Parks, by visiting fwp.mt.gov/news/restrictions.

A map of fire restrictions by county can be found at firerestrictions.us/mt.

Hunters and anglers can help prevent wildfires by adhering to fire restrictions; making sure campfires are completely out and following road and travel restrictions.

ND Fall Turkey Season Set, Application Deadline Sept. 2

North Dakota's fall turkey season is set with 3,785 licenses available to hunters, 125 more than last year.

Unit 47 (Eddy, Foster, Kidder, Sheridan, Stutsman and Wells counties), which has been closed to fall turkey hunting because of low numbers, is open due to an increase in turkeys in the northern part of the unit. Unit 21 (Hettinger and Adams counties) will remain closed because of a low turkey population.

Fall turkey hunters, including gratis applicants, who are interested in applying for a 2020 license can submit an online application through the North Dakota Game and Fish Department's website, gf.nd.gov.

Applications are also accepted by calling 800-406-6409. A service fee is added for license applications made over the phone. The deadline for applying is Sept. 2.

Only North Dakota residents are eligible to apply in the first lottery. Nonresidents can apply for fall turkey licenses that are still available following the first lottery.

The fall wild turkey season runs from Oct. 10, 2020-Jan. 3, 2021.

Montana FWP Seeks Public Comment On Ice Fishing Contest

Montana Fish, Wildlife & Parks is seeking public comment on ice fishing contests proposed for the 2020-2021 season. Participants must comply with state fishing regulations, including daily and possession limits.

Applications for fishing contests may be approved, approved with conditions, or denied by the FWP Fisheries Division in Helena. Conditions placed on contests may help to minimize fish mortality, regulate harvest, reduce user conflicts, and/or require additional access site maintenance when needed.

Governor Bullock Announces \$100,000 Award Through Farmer Student Loan Assistance Program

Program encourages young Montanans to pursue careers in agriculture

MONTANA – Governor Steve Bullock has announced nearly \$100,000 has been awarded to 12 applicants through the Montana Farmer Student Loan Assistance Program, which was created to encourage Montana's college-educated youth to pursue a primary career in farming or ranching.

The program also seeks to reduce financial stress on farm and ranch operators and promote succession planning to preserve interest in the state's agricultural future.

"With the average age of producers in Montana at nearly 60 years old, it's critical we invest in young folks and ensure there's a path to a sustainable career in agriculture," Governor Bullock said. "This program is vital to the future of Montana's ag industry and supports our young producers by removing financial barriers and encouraging younger Montanans to pursue careers in farming and ranching."

The Montana Farmer Student Loan Assistance Program originated during the 2019 legislative session as House Bill 431 sponsored by Representative Zach Brown. This is the first round of awards made through the program and determined by the Agricul-

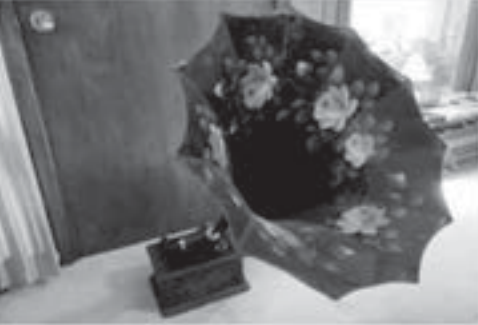
