Long X Trading Post Summer Event Set For June 20

Starting at 11 a.m. on Saturday, June 20, at Long X Trading Post 2nd Ave SW, Watford City, there will be a Welcome to Summer Open House. At the event, there will be many opportunities for all ages to get out and have some fun.

With many events being canceled due to COVID-19, the Pioneer Museum of McKenzie County, McKenzie County Tourism, and the Long X Bottle Shop wanted to provide some summertime fun for the whole community to partake in.

The Long X Art Foundation will be doing children activities at the play park, the Long X Bottle Shop will have a motocross display and autographing in addition to having company vendors and samples. The Watford City Lions Club will be serving their famous \$5 burgers at Centennial Park.

"So many things have been canceled due to COVID-19, and we are hoping that this event will bring everyone together in a safe and fun way - while still implementing COVID-19 social distancing recommendations," said Pioneer Museum director, Jan Dodge.

The Pioneer Museum of McKenzie County has recently been renovated as of this past winter. The museum's lower level has been completely remodeled, as there is now an updated McKenzie County Economic Development Exhibit, a new Oil History Room, and digital displays/exhibits that elaborate on the economic development in McKenzie County.

"I am really excited to share what we have done as far as renovation this past winter. We have new displays that tell our story about economic development in our county. We have a three-prong realization that talks about ranching and farming and how these are the first non-native economic development in McKenzie County. We want to share with people the force of agriculture in North Dakota. We have storyboards that talk about how important farming and ranching is to the people that live in McKenzie County," explained Dodge.

The Pioneer Museum of McKenzie County has also built a timeline that runs from the early 1800s all the way to 2020. "We have some graphs that talk about population growth - so you can visually see where we were then and where we are today. There is one graph that shows the growth of the county budget and the growth of school enrollment. There are also visuals and digital e-posters that will help people understand and visualize the growth of McKenzie County. We hope that everyone can come and learn about us, es-

pecially the new pioneers of McKenzie County," said Dodge.

In addition to providing information on McKenzie County, the Pioneer Museum will be serving free root beer floats throughout the day to celebrate National Ice Cream and Soda Day.

The Welcome to Summer event is sponsored by the Long X Trading Post Pioneer Museum, McKenzie County Tourism, and the Long X Bottle Shop. Dodge added, "All of us working together to throw something out there for people to enjoy and to welcome summer. We are looking forward to do some fun things!"

Changes to Froid Research Farm Webinar Schedule

While COVID-19 has prompted the cancellation of the annual onsite Froid Research Farm Field Day typically held in late June, two live webinars are planned to provide interested participants with important information on range and cropland weeds in the MonDak with a special emphasis on identifying and preventing the introduction of Palmer amaranth in Montana, a dangerous herbicide resistant crop weed that has recently made its way into North Dakota.

The webinars were originally scheduled for successive Thursdays, but have now been moved to the mornings of Thursday and Friday, June 25-26. Thursday's presentation will begin at 8:30 am, while Friday's presentation will begin at 7:30 am. The presentations are expected to last an hour each. Pesticide points for both presentations are also pending.

Please note, participants will need to provide their applicator license numbers at the time of the webinar to receive credit. Also, plans are to post recordings of both webinars on the Sidney ARS website (www.ars.usda.gov/pa/npa/fieldday); but pesticide points are only available for those participating in a live session.

For those interested, Thursday's webinar is entitled "Palmer amaranth Identification and Management and Herbicide Resistant Weeds" and is being presented by Richland County Extension Agent Tim Fine. He will discuss how to identify the weed and distinguish it from other pigweed species to prevent the introduction of this devastating crop weed into the region, as well as what steps should be implemented if a person believes they've found the weed. Fine will also discuss steps to prevent herbicide resistance, a known trait in Palmer amaranth in other parts of the country. Fine will also address other herbicide-resistant crop weeds that have already been identified in Eastern Montana.

Friday's webinar is entitled "Noxious Weed Identification: Present and Potential Invaders" and includes tips on identifying noxious rangeland weeds commonly found in the MonDak, along with those threatening to invade. The presenter is NPARL Biological Science Technician Kim Mann, who has more than 30 years experience with weed identification and biocontrol and who also frequently provides weed identification instruction to local and regional weed districts and their employees. In addition to an overview of listed and threatening noxious weeds in the state and tips for identifying them, Mann will also discuss locally listed weeds such as baby's breath currently considered a noxious weed in Richland County.

While the June Froid Research Farm Field Day has been canceled for this year, updates on research at the site will be posted on the Sidney ARS website, along with additional research being conducted by NPARL scientists. The Froid Field Day event is regularly sponsored by the USDA-ARS Northern Plains Agricultural Research Laboratory (NPARL) in Sidney, the Roosevelt and Sheridan Conservation Districts and the Roosevelt and Sheridan County extension offices.

Also upended by COVID-19, the joint Sidney Dryland Field Day sponsored by the Sidney ARS lab, Montana State University's Eastern Agricultural Research Center (EARC) and the Richland County Extension office has also been cancelled, but will return as an every other year event in 2021, according to officials from both Sidney research labs.

Richland County Health Department Urging Businesses to Revisit their Internal Policies

Richland County – June 10 - The Sidney Area Chamber of Commerce, and the Richland County JSEC (Job Service Employees' Committee) teamed up with members of the Richland County Health Department to hold a Zoom videoconference.

The teleconference focused on answering questions posed to health department staff by local business owners regarding reopening after the Coronavirus shutdown and on revisiting internal policies.

Stephanie Ler, Richland County Public Information Officer, answered questions pertaining to the frequency required of cleaning public bathrooms, wearing masks, and wearing gloves. Ler recommended cleaning bathrooms and commonly touched areas every hour and using masks when you cannot social distance. Ler stated, "Gloves are single use. Use them 1 time only." She then reiterated the importance of frequent hand washing, especially if a person is dealing with money.

Revisit Internal Policies

Northeast Montana Retired and Senior Volunteer Program (RSVP) Director and Logistics Coordinator, Jessica Gilbert, urged businesses to revisit their internal policies. She recommended businesses look at some of the following areas:

1) Work from home policy – "If you do not have one, maybe take a look at implementing one."

2) What items will your employees need to have to work from home – tools, computers, etc.

3) Communication policy - How will you communicate with your staff and clients? Do you have a call tree in place?

4) Sick Leave – Is your sick leave policy broad enough or is it too strict?

5) Cleaning policy – Revisit this

6) Trigger Points – What triggers your business to activate a policy?

7) Extended Family Leave – Do you have an extended leave policy for employees who have to stay home with family? Example: When schools closed, kids were required to stay home, and some parents had to stay home with them.

8) Do you know how to access different agencies that can help you find the information or resources your business may need? Examples: Health departments, disaster relief agencies or law enforcement agencies. Do you have their contact information?

9) Emergency Plan – "It's really important to have an emergency plan in place."

Gilbert stated, "We recommend an Incident Command Structure. It is a FEMA structure. This allows you to implement that framework within your organization. It helps you identify resources and how to interact with them." Classes are available online through www.ready.gov or www.fema.gov.

Summer Storms: Reminder To Cover Crops With State Hail Insurance

Submitted by Chelsi Bay

Helena, MT – In light of recent severe weather events, the Montana State Hail Program reminds producers that now is an opportune time to make sure crops are covered. Staff is available to accept policies, file claims, and to answer any questions producers might have regarding coverage options.

Producers can insure crops against hail damage at the maximum coverage rate of \$75 per acre for dryland and \$114 per acre for irrigated land. Rates charged are a percentage of the insured amount and vary by county. A detailed list of rates by county and crop can be found at <https://agr.mt.gov/HailInsurance-Rates>. State policies are available for purchase until Aug. 15, 2020.

State hail insurance application forms are available online or by calling the office. Completed forms can be emailed, mailed or faxed to the department, or used as a reference when you contact the office by phone. Loss claim forms are also available online for producers reporting losses. Loss claims are due to the office by Oct. 1, 2020 and must be submitted within two weeks of the hail damage occurrence.

The Montana State Hail Insurance program was created at the request of producers in 1917 to provide basic hail insurance coverage on any crop grown in Montana. A five-member board consisting of the department director, state insurance commissioner, and three policyholders directs the program.

The Montana Department of Agriculture's mission is to protect producers and consumers, and to enhance and develop agriculture and allied industries. For more information on the department, visit agr.mt.gov.

USDA's Farm Aid Package Leaves Malt Barley Growers Behind

A Message From MT Farmers Union Board Director, Erik Somerfeld

"The Coronavirus Food Assistance Program or CFAP gives producers of certain commodities or livestock assistance for losses caused by the coronavirus. The USDA claims that CFAP includes coverage for malt barley, but the rules indicate differently. While on the list of non-specialty crops that are eligible, it is almost impossible to qualify for the assistance. As a farmer who grows malt barley in the golden triangle I know this first-hand.

First, almost all malt barley is contracted with a malt company long before it is planted. This makes it ineligible because it is not "at risk" for the price decline that is the basis for the program. However, it is "at risk" if it hasn't been delivered and is still in the bin. To get the price in the contract, you must meet the quality specifications in the contract. If you don't it is considered feed barley and sold at a much lower price.

The longer the barley is stored the less likely it is

to meet the necessary standards due to germination. Some growers have been told that they may not be able to deliver the remainder of their 2019 crop until possibly 2021. This is due to reduced demand caused by coronavirus, and has caused malt buyers to cut contracts.

In addition, malt companies have first rights on the crop. This prevents growers from selling to another buyer. Contact your congressional delegation today and insist on CFAP protection for malt barley growers."

White-Nose Syndrome Kills ND Bats Near MT Border

Disease has killed 6.7 million bats in North America since 2006

So far, Montana Fish, Wildlife & Parks hasn't found signs of the deadly white-nose syndrome (WNS) in the state's bat populations, but biologists are closely monitoring the situation. Recent reports of bat deaths from WNS just over the border in North Dakota make monitoring efforts even more critical.

"Bats provide important services in protecting crops and timber from flying pests," said Lauri Hanauska-Brown, Montana FWP nongame wildlife management bureau chief. "Bats also eat tons of mosquitoes each year, meaning they play a role in reducing the spread of some mosquito-borne diseases. Like we do for all wildlife, we are doing what we can to keep bat populations healthy."

WNS has been in North America since at least 2006, killing an estimated 6.7 million bats. A powdery white fungus grows on the skin of hibernating bats, often on the face – hence the name "white nose." The fungus causes a number of problems, one of which is that it irritates bats, causing them to arouse early from hibernation and search for water and food. Food is obviously scarce in winter, and this early arousal can exhaust fat stores that bats need to survive the winter.

WNS has been confirmed in 35 states and seven Canadian provinces. It can wipe out entire colonies of bats and has caused dramatic population declines in eastern states.

This month the North Dakota Game and Fish Department reported a cluster of little brown bat deaths from WNS just over the Montana border. The first week of May, the department learned of at least 20 dead bats found in Medora. Six were submitted to the USGS National Wildlife Health Center in Madison, WI. for analysis. The bats all tested positive for the fungus *Pseudogymnoascus destructans*, the culprit behind WNS.

"This is the second time that the fungus has been detected in the state, but these are the first documented deaths in bats attributed to WNS," said NDGFD Conservation Biologist Patrick Isakson, while noting it was roughly a year ago that the fungus was found on a live bat within the boundary of the Knife River Indian Villages National Historic Site.

FWP has temporarily prohibited the capture of all live bats due to unknown risks of COVID-19-infected humans inadvertently transferring the virus to bats. To substitute for sampling of live bats, the collection of bat droppings at eastern Montana roosts has begun to look for signs of WNS. Biologists are visiting known roost areas, including the undersides of bridges, and collecting samples. WNS is not known to affect humans, pets, livestock or other wildlife.

"The discovery of white-nose syndrome in these bats

signals the continued expansion of this invasive pathogen through North America," said Jeremy Coleman U.S. Fish and Wildlife Service national white-nose syndrome coordinator, which leads the national response to WNS. "It also highlights the need for continued vigilance to track the spread of the disease and the impact it is having on native bat populations so we may better focus our conservation efforts."

State and federal agencies are asking for help to monitor the spread of this disease. Anyone seeing a dead or sick bat, or group of bats, is asked not to handle them, but to notify health officials or state biologists, who can provide further guidance. Callers can reach Montana Fish, Wildlife & Parks at 406-228-3725 in FWP's Region 6, or at 406-234-0948 in FWP's Region 7.

"Like other wildlife, bats can be sick or die for a variety of reasons," said Emily AlMBERG Montana FWP disease ecologist. "We are particularly interested in investigating clusters of dead bats or bats that are found dead during the winter or early spring."

RMC Hopes to Light up RMC

It's 3 p.m. and an elderly resident thinks ice cream would pair perfectly with the cup of coffee a nurse has just delivered to her room. She reaches across her bed and presses her call light. Shortly after, a nurse comes in, hears her request and returns with a scoop of vanilla ice cream. Down the hall, a patient would like pain relief medication. He presses his call-light button and a nurse comes to deliver his pill.

While the idea of pressing a button and having someone respond to your every need might sound enticing to anyone, at Roosevelt Medical Center, the call-light system serves as the heartbeat of the facility, ensuring patient safety while caring for the needs of patients at every hour.

At the nurse's station, the call-light system creates a steady stream of beeping sounds that coincide with lights flashing from small boxes above patient room doors. As call-lights are answered, nurses reset the button and continue responding to call-lights as they go off.

After 42 years of use, the system has become obsolete and needs replacing.

For the past year, Roosevelt Medical Center and the Roosevelt Memorial Healthcare Foundation have been working to raise funds to replace the system. Last year, a total of \$30,000 was raised from the Fall Fest Fundraiser. Another \$16,000 is needed to complete the update.

Recently, the RMHF met via Zoom to discuss future fundraising activities for the non-profit organization. With the community's best interests in mind, the Board voted to cancel their annual Fall Fest Fundraiser usually held in October, in response to the pandemic. "Uncertain times make it difficult to plan a fundraiser and the Board believes it is simply too big to ask our community to go out and seek sponsorships," said Jaimee Green, Foundation director.

Without a fundraiser, it will be impossible to complete the project in 2020. "It's hard to go an entire year without hosting an event that helps ensure we continue to innovate as a facility. Providing quality care requires medical equipment that can do the job," Green added.

MT 200 Fairview Construction Project Update

The MT 200 - Fairview road reconstruction project remains ahead of schedule. Electrical work has finished and crews are focused on concrete pouring. Motorists should be driving on all new concrete pavement on the east side of MT 200 (Ellery Ave) by the end of June.

Construction crews will stop working on Thursday, July 2 by 12 p.m. and return on Monday, July 6. Traffic will remain reduced to two-lane, two-way traffic but the highway will remain open to motorists during the Fourth of July Weekend.

There are no additional traffic impacts planned for motorists traveling through the area and traffic will continue flowing. Traffic will remain reduced to two-lane, two-way traffic but the highway will remain open to traffic during construction. The traveling public is asked to prepare for occasional delays of up to 15 minutes and is reminded to slow down and watch for work crews and equipment in the construction zone.

With the hope of completing the project this year without making a large ask of the community, the board decided to host a Light Up RMC raffle.

Participants who give over \$200 will also receive a plaque in memory or honor of a person of their choosing to be displayed at RMC as part of the Light up RMC project.
