## ND Officials Tour LYIP NDRA Finals

### Rodeo, Sept. 29 & 30 in Watford City

Witness top rodeo cowboys and cowgirls vie for North Dakota State Championship Titles at the 64th Annual North Dakota Rodeo Association State Finals in Watford City on September 29th and 30th.

The rodeo is hosted by the McKenzie County Cowboys Association, and will also feature the top rodeo horses and bulls from each of the stock contractors, so the night is sure to be full of excitement!

The two-day event begins on Friday, September 29th at 7PM Central Time at the McKenzie County Fairgrounds Multipurpose Building indoor arena in Watford City. On Saturday, September 30th, jackpot barrel racing will begin in the outdoor arena with exhibition at 8AM Central and open at 10AM, with a \$1500 purse. Youth barrel racing will also take place at the same time. Registration is open until the day of the race, or contact Kendel at 701-570-4591 or Monica at 701-629-1982.

The Saturday evening rodeo begins at 6PM Central at the Fairgrounds. Both rodeos feature men's and women's events, including bareback, bull riding, bullfighters, ladies barrel racing and breakaway, saddle bronc, steer wrestling, team roping, and tie down. Participants will be competing for the state title as well as a cash prize, saddle, buckle, or other prizes.

Concessions and vendor booths, including horse trailers, jewelry and other exhibits, will be available before and during the rodeos. A dance will follow the rodeo each night, with alt and vintage country music provided by North Dakota band Lonesome Willy.

Entrance to the rodeo each evening is \$15 for adults, and \$10 for students and seniors.

### A Fiddle, A Flute, and Some Friends, October 1st

Pastors Alvina Olstead and Melanie Martin-Dent will be hosting a musical program called "A Fiddle, A Flute, and Some Friends", at Pella Lutheran Church in Sidney on Sunday, October 1, at 3:00.

Pastors Olstead and Martin-Dent developed the program after weeks of unsuccessfully planning to practice music together. Olstead, Pastor of the Ebenezer and Froid Lutheran congregations, is a fiddle-player, and Pastor Martin-Dent, of Lonsdale Methodist Church in Sidney, is a flute player. The pair had intentions to practice together, but could never seem to get together. Olstead had the idea to invite others to play together as a fundraiser, and thus the name was born.

Admission will be a free-will offering that will support the Freedom in Christ Prison Ministry. The ministry is supported entirely by donations, and was started by the ELCA, the Evangelical Lutheran Church in America. As Martin-Dent explained, "the state no longer provides a prison chaplain at the men's state prison in Deer Lodge. The Ministry provides a full-time prison pastor, who provides worship services, counseling, baptisms, and Bible studies". Martin-Dent is the chairperson for the Ministry Council, and was on board with Olstead's idea for the event.

Olstead and Martin-Dent will be joined by vocalist Mary Pfau, singer and guitarist Pastor Wade Brinkhopf, the Sunrise Brass Ensemble, and a Sidney High School choir ensemble. Music will vary from classical, to hymns, to popular music.

Enjoy a variety of music from local artists and support the Freedom in Christ Prison Ministry at Pella Lutheran Church at 3:00PM on Sunday, October 1st.

Officials from North Dakota traveled to Richland County on Sept. 21 to tour the Lower Yellowstone Irrigation Project. North Dakota Lieutenant Governor Brent Sanford, McKenzie County Economic Development Coordinator Daniel Stenberg and McKenzie County Commissioner Gene Veeder were in attendance. The officials were invited by LYIP Project Manager James Brower and Chairman of the Board of Control Richard Cakyo to tour the irrigation project and gain a better understanding of its importance to the region. The Lower Yellowstone Irrigation Project extends from Intake north east of Glendive past East Fairview in North Dakota, all the way to the Snowden Bridge on the Missouri River. The canal brings water to 18,730 acres of irrigated land in McKenzie County.

In addition to Richland County the Sidney Sugars factory takes beets from Trenton, ND, Terry & Culbertson, MT. A couple of years ago Sidney Sugars indicated that if they had a 25% reduction in the reliability of irrigation in this valley, they would shut down and that would affect the beet growers as far away as Terry, Culbertson and Trenton and those town's economies.

Brower began by showing the officials the entirety of the project on a map in the LYIP office and presented historic photos of the project's beginning in 1904. The tour then made its way to Intake for a first hand look at the headwaters of the canal with a drive through Fox Creek to view wildlife habitat that did not exist

prior to the canal's construction. While at Intake the group had the opportunity to look over the historic and existing facilities and Brower explained the proposed improvements. The tour then proceeded to the Sugar Valley operations in East Fairview.

The Lower Yellowstone Irrigation Project, U.S. Army Corp of Engineers and Bureau of Reclamation have been trying to proceed with improvements to the current structure at Intake and construction of a fish bypass to help the endangered pallid sturgeon reproduce. The improvements will aid the pallid in travelling up the Yellowstone River to spawn with enough distance for their larva to develop as they flow downstream toward Lake Sakakawea.

Environmental groups headquartered outside the area have persuaded federal judge Brian Morris to implement an injunction on proceeding with improvements. Despite over 15 years of study into the proposed project, the Defenders of Wildlife and Natural Resources Defense Council argue that there has not been enough data to prove the new structure is certain to recover the species. They have also asked the judge to take things one step further and rule that the current structure is in violation of the Endangered Species Act and the National Environmental Policy Act. The current structure at Intake was authorized by the Secretary of the Interior in 1904 and is protected by law from the U.S. Congress prior to the passage of both environmental acts.

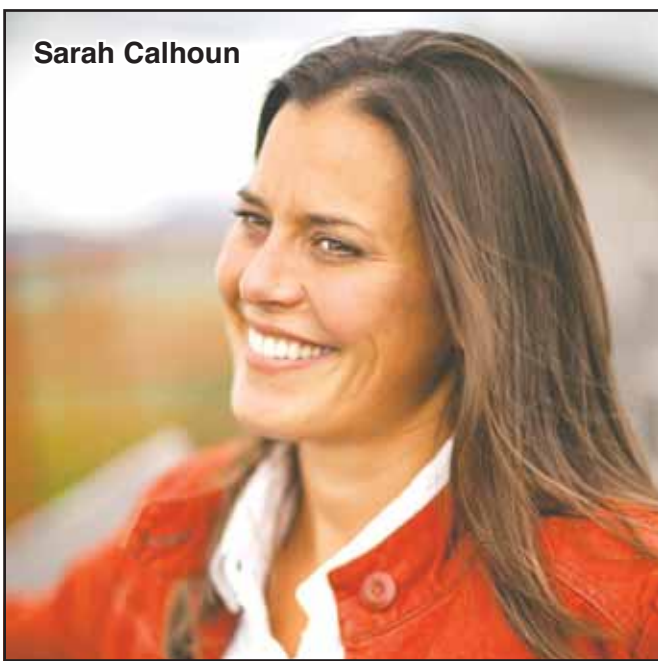
and has been featured on national television programs such as CNBC, CNN, and Bloomberg.

## Vigilantes Alive and Well in Virginia City

Most people have heard of those famous, or infamous depending on whom you talk to, vigilantes that ruled the streets of Virginia City in late 1863 and early 1864. These citizens took it upon themselves to rid the town of unsavory characters and they did so with gusto, hanging at least twenty people in a six week period. These vigilantes vanished from the forefront in 1864 with the arrival of a district judge, but their legend lives on in books and tall tales.

It appears that a tiny band of modern day vigilantes has recently risen from the dust of the past to establish a benign rule on an obscure dirt road located on the outskirts of Virginia City.

The saga of these modern day vigilantes began with the naming of that unpaved road. Cornucopia Road leads out of Virginia City and meanders up a mountainside. Along that Cornucopia Road, five different dwellings exist, each on its own little dirt path or driveway leading to the house. Four of those six roadways offer no throughway, as they dead end at the house itself or shortly beyond the living quarters.

The local emergency services would like to see these roads named in order that emergency personnel can locate these homes in case any type of emergency situation should occur. I have always thought it would be a hoot to live on Lois Lane, so I petitioned the County to have our dead end road formally named ‘Lois Lane’. The one other landowner who lives along that lane, along with a third landowner who owns property on the other side of the roadway, all agreed to call that little gravel road Lois Lane. We filed the appropriate paperwork with the County and a few weeks later we had our official road name of Lois Lane.

Two couples live on Lois Lane. My husband and I live here year round while the other couple, our very dear neighbors, at this point still have a home in Nevada so they only live here during the summer season. As good



neighbors will do, we try to look out for one another at all times.

All four of us began calling Lois Lane ‘home’ this spring. My husband and I became permanent residents here in April, our neighbors stay for the summer, but since they come and go, we keep an eye on their property when they leave town for any length of time.

In early May, my husband and I noticed some activity on the neighbors’ land while they were in Nevada. We assumed the intruder in question had a legitimate reason for loitering at the neighbors’ shop site, but just to make sure, we put in a call to our neighbors to alert them of the presence of unknown people. I said to my dear neighbor and friend, “If that person ought not to be on your property, let us know and the Lois Lane Vigilantes will spring into action and take care of the problem.”

That started it all. Lois Lane vigilantes became our buzz word, a common theme, and a phrase that we used regularly in jokes and in idle conversation. Our neighbors showed up in June for the summer, and the Lois Lane vigilante comments cropped up repeatedly in conversation.


A few weeks later, our neighbors gifted us with LLV shirts, with a nice LLV logo on the front, complete with images of bullet holes above the LLV logo. On the back of the shirts the words ‘Lois Lane Vigilantes’ show up in bold letters, along with an image of a noose and a mean, derelict-looking cowhand.

Now that the four of us had nicely matching shirts declaring who we were, we decided this required regular meetings of the vigilance committee. We opted to meet once a week. None of the four of us particularly like wasting our time on dry boring meetings, so we laid a few ground rules. These rules included the stipulation that each member would bring the adult beverage of his or her choice to the meetings to help the sessions move smoothly, and we would talk about whatever our hearts desired at these meetings, rather than following some stuffy agenda.

What fun. I wish all the meetings I had to attend had such important rules as these.

This August, a week before our fellow vigilantes had to return to Nevada for the winter, we met at the Wallace Street Photographic Emporium in Virginia City and had an official Lois Lane Vigilante picture taken. We figured if history ever wanted to remember us for any reason, someone somewhere might still have a photo in existence that would satisfy historians as to who these modern day vigilantes really were and what they looked like. Thanks to this photo, we now have proof of the existence of this group: two grizzled old men who hadn’t shaved for a week in preparation for the photo shoot, one gorgeous Vigilante lady (not me, unfortunately), and one wrinkled old prune (me) of a vigilante woman who can still wield a rifle and shoot it with accuracy. Don’t forget the vicious Doberman, our mascot who always stands ready for the attack at a single command.

Criminals, beware. The Lois Lane Vigilantes represent one dangerous group of human beings and one snarly dog.





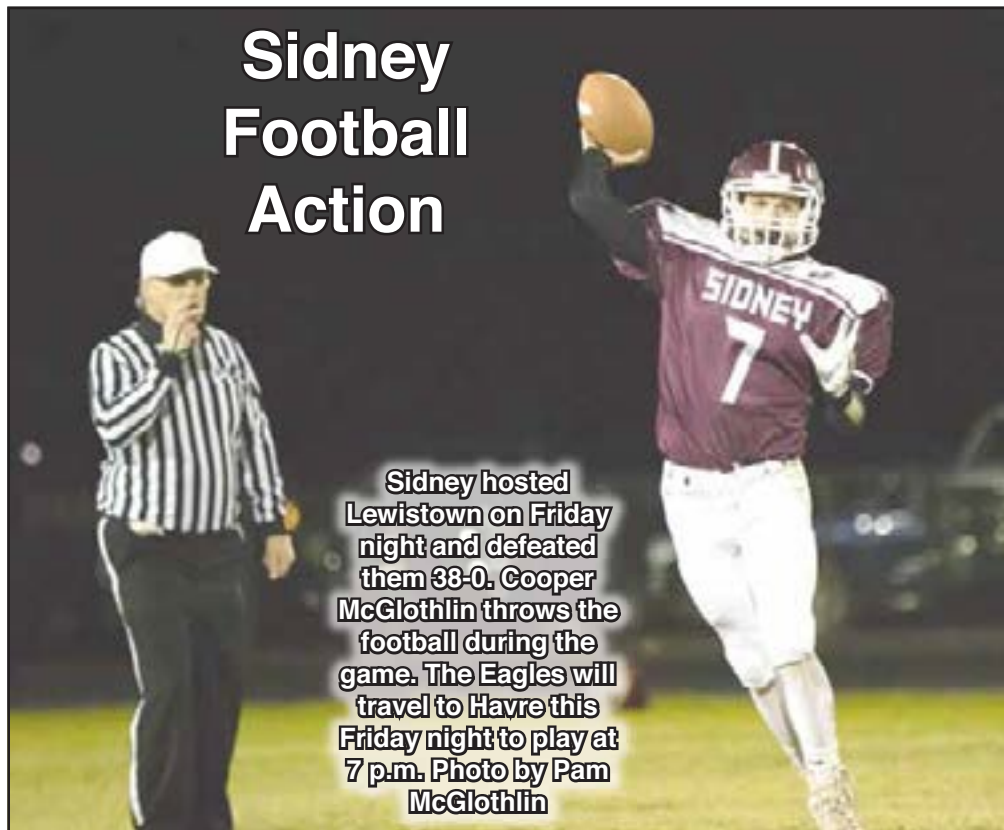

# Flu Myths... Busted!

There are so many myths about the flu and the flu shot all over the internet, so in preparation for the Mass Flu Shot Clinic at the Richland County Health Department on October 5th, we've busted a few myths wide open.

If your neighbor says he had a touch of the flu and couldn't leave the bathroom, you've heard firsthand one of the big myths about the flu. The flu is actually caused by the influenza virus, and is a contagious respiratory illness, not a stomach virus. Symptoms include sudden onset of cough, chest discomfort, fever, chills, and body aches. The real flu can actually lead to death, and is especially risky for those who already suffer from respiratory conditions like asthma or COPD, or those with compromised immune systems, such as those undergoing cancer treatment or the elderly. Last flu season, there were 7935 positive cases of influenza in Montana, with 829 people hospitalized and 56 deaths.

If the same neighbor said his flu shot last year made him sick, he's really lacking in his influenza education. The flu shot vaccine does not contain any live virus, so it actually can't make you sick with the flu. The vaccine contains inactivated virus, which means that once it's in your body, your immune system can learn to respond to components of the virus, so that if you do come across the real flu virus, your body will be prepared. Because vaccines are designed to evoke an immune response, it is common to have injection site soreness or a slight fever, but these symptoms shouldn't last long. The Vaccine Information Sheet, offered either at the beginning or the end of your vaccination clinic visit, explains potential risks and reactions.

If you're considering skipping the flu shot this year because you exercise and eat healthy, reconsider your decision. The flu virus doesn't discriminate, and even healthy people can become infected. The flu virus can be spread when a sick person sneezes, coughs or talks, or spread by surfaces shared by both sick and healthy people, like doorknobs in public, bathroom faucet handles, and shopping carts. You may lose income due to days off from work, or may face more serious consequences of the flu, such as hospitalization and death.

There are many reasons to get your flu shot this flu season. If you have questions or need help with the decision to get you and your family vaccinated again the flu, contact the Health Department at 406-433-2207.

Flu shots are available for those 6 months and older at the Richland County Health Department during normal clinic hours, and at the Mass Flu Shot Clinic on Thursday, October 5th, from 10AM to 6PM. Private insurance, Medicare and Medicaid will be billed for those who bring their insurance cards. No appointment is needed for the Mass Flu Shot Clinic on October 5th. # DEQ Holds TENORM Forum in Sidney

The Montana Department of Environmental Quality (DEQ) held a public hearing on Wednesday, September 20, at the MonDak Heritage Center in Sidney. The DEQ hosted the hearing to inform the public regarding proposed waste management rule changes for Technologically Enhanced Naturally Occurring Radioactive Material (TENORM).

Naturally occurring radioactive material (NORM) is any substance that contains radioactive isotopes, and it is regularly present in different kinds of common rocks and soil. TENORM is radioactive material that has been concentrated in larger-than-ordinary amounts as a byproduct of mineral extraction. TENORM is not nuclear waste, but may still potentially expose humans to particles dangerous to their physical wellbeing. In Montana, TENORM waste disposal facilities are regulated by a number of legal codes for environmental protection and waste control under state – and not federal – jurisdiction.

The Montana Environmental Protection Act requires public participation in the DEQ evaluation of disposal sites, and fulfilling that legal obligation, the DEQ sought comments from the public regarding the adoption of a new subchapter relating to TENORM administrative-wide policy. Although there is currently only one such disposal site in Eastern Montana, located at the Oak's facility near Glendive, there is a demand for more sites but no statewide administrative rules governing TENORM waste specifically. A number of residents spoke to these proposed changes.

The Roundup spoke to Ed Thamke, the Waste Underground Tank Management Bureau Chief for the DEQ, who explained the changes, saying, "The whole idea with the proposed rule making for TENORM is to provide a regulatory structure that is specific

to that kind of waste management. There's a well established policy for normal solid waste management, like landfills, but every now and then a new waste stream comes up that isn't already specified in policy."

Thamke reiterated that the proposed changes will be applying very similar rules already included in the specific license issued to the Glendive TENORM facility, but will make it an administrative, state-wide policy that will be enforced widely instead of on a case-by-case basis. This is important, according to Thamke, because there is a demand for more TENORM facilities and it will require clear administrative guidelines.

"When the Bakken boom happened, we found a situation where waste was being imported into Montana because our regulatory structure allowed it. So, there became a demand to manage this sort of waste. We did have standards for TENORM, but it was a part of the operating license for the [Glendive] facility, and not in the administrative rules. The main point is so that people who want to manage such a facility know what will be required of them, and not vary from site to site."

Thamke continued, "We have two other facilities that have been licensed, but not constructed yet, and have a third license request in Eastern Montana as we speak. One location is in Culbertson, another near Bainville, and an environmental assessment is now being conducted near Sidney."

The hearing to discuss these proposed changes to DEQ policy began at 7 p.m. and lasted for nearly two hours, with Jeni Garcin – a DEQ officer – leading the meeting with an explanation of rules and introduction of the topic. Many Eastern Montana residents gave comment, most in favor of proposed rules and many asking that the rules be tightened even further than proposed.

Rachel Torres, of Glendive, urged DEQ to be proactive in protecting Montana resources. Torres claimed that Buckhorn Energy, which owns the Oaks Disposal site in Glendive, does ground-testing four times a year already, but still has concerns. Torres said, "I have several thoughts about this. If it's already being done, why wouldn't it be written into the rules already? Secondly, if the company is hiring someone to do the testing, they're still on the company's payroll. Other states have the company pay DEQ, who then hires a truly independent company to do the testing."

Ali Davis, another resident of Glendive, also spoke of his concerns. Davis, who is now an employee of the railroad, says he once had a career in waste testing and he has concerns with exactly how well the site is being tested and reiterated safety concerns for employees as well as residents, "We're all concerned about water, for surrounding farmers and ranchers. But, I'm also worried about the workers. I think it's good that the rules included would provide radiation training. They may outsource that to another company, but how do you know that company has properly trained their employees to do it?"


Robert Morris, who said he spent his career doing radiological control, works for the Oaks TENORM facility as a consultant. He claimed that both he and the facility itself are in favor of the proposed changes.

"My first ethical obligation is to assist human health and the environment. Having said that, I work for Oaks Landfill and both Oaks and myself support the rules. There are already guidelines, and these rules are similar to the existent guidelines."

Morris continued, "All measurements need to be done with a quality assurance plan and they need to be accurate. We also need fence line monitoring to assure that neighbors don't have excessive exposure to radiation. And third, we need to monitor the exposure of the workers."

Donna Quick, from south-east of Circle, said, "I am very pleased with the rule process as it has been done. Many years ago, my late husband and I determined how precious water is to our lives and resources, and how water is now and would become increasingly important. I would like to ask the DEQ to give careful consideration to all of the testimony you've received tonight."

# 2018 NAP: USDA Encourages Producers to Consider Risk Protection Coverage: Oct. 2 Deadline

Montana producers have until Oct. 2, 2017 to sign-up for FSA's Noninsurable Crop Disaster Assistance Program (NAP) coverage for all 2018 Annual Fall-Seeded Crops, Perennial Forage and Grazing, Mixed Forage Crops (includes spring seeded annual types of mixed forage), Rye, Speltz, Triticale, Wheat and Garlic.

NAP provides a catastrophic level (CAT) coverage based on the amount of loss that exceeds 50 percent of the expected production at 55 percent of the average market price for the crop. NAP offers buy-up coverage for the 2015 through 2018 crop years in addition to the basic CAT-level coverage, on all crops except those intended for grazing. These additional coverage lev-

els range from 50-65 percent of the expected production, in 5 percent increments, at 100 percent of the average market price.

In order to meet eligibility requirements for NAP, crops must be noninsurable, commercially-produced agricultural commodity crops for which the catastrophic risk protection level of crop insurance is not available. If the Risk Management Agency (RMA) offers coverage for a crop in the county, NAP coverage is not available for that crop. For questions regarding insurability of a crop, please contact your local crop insurance agent. For information on whether a crop is eligible for NAP coverage, please contact your local FSA office.

The NAP service fee for

all coverage levels is the lesser of \$250 per crop or \$750 per producer per administrative county, not to exceed a total of \$1,875 for a producer with farming interest in multiple counties. In addition to the service fee, producers who elect buy-up coverage must pay a premium equal to the lesser of 5.25 percent of the guarantee or 5.25 percent of the payment limit. FSA will waive NAP service fees and reduce buy-up premiums by 50 percent for underserved, limited resource, and beginning farmers. For questions regarding how to calculate the premium, please contact your local FSA office.
